## Certification of Vaccination for Visitors to Non-public Spaces

The purpose of this form is to take steps to prevent the spread of COVID-19, to protect the health and safety of all National Gallery employees, onsite contractors, visitors to National Gallery buildings or National Gallery controlled indoor workspaces, and other individuals interacting with the National Gallery workforce. If you fail to submit this signed attestation or any required negative COVID-19 test, you may be denied entry to a National Gallery facility.

### My Vaccination Status

By checking the box below, I declare that the following statement is true:

- I am fully vaccinated.<sup>1</sup>
- I am not yet fully vaccinated.<sup>2</sup>
- I have not been vaccinated.<sup>3</sup>
- I decline to respond.

**I understand that if I decline to respond or am not fully vaccinated, I must comply with the following additional safety protocols while at the National Gallery, in addition to the ones already in place (such as wearing a mask at all times):**

- Physically distance; and
- Provide proof of having received a negative COVID-19 test from within the previous 3 days.

I sign this document under penalty of perjury that the above is true and correct, and that I am the person named below. I understand that a knowing and willful false statement on this form can be punished by fine or imprisonment or both (18 U.S.C. 1001). Checking "I decline to respond" does not constitute a false statement. I understand that, if I am a Federal employee or contractor, making a false statement on this form could result in additional administrative action, including an adverse personnel action up to and including removal from my position or removal from a contract.

<sup>1</sup> The Centers for Disease Control and Prevention considers an individual fully vaccinated if they are:

- 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or
- 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine.
- If you don't meet these requirements, regardless of your age, you are not fully vaccinated.

<sup>2</sup> Either I have received my first dose of Moderna or Pfizer, and my second appointment is scheduled, or I received my final dose less than two weeks ago.

<sup>3</sup> If you are not vaccinated due to medical or religious reasons, please check either "I have not been vaccinated" or "I decline to respond."
